### URGENT DOCCA ALERT:

AFC had someone approach us who wishes to remain anonymous. This person indicated that if we can raise \$9,000 by October 15, 2010 they would match those funds.

## SOMB UPDATE

### ***SOMB 4th Annual Conference Report***

Theme: New Directions and Innovative Practices

The general theme echoed by most workshop presenters and both keynote speakers was one of collaboration involving those charged with a sex offense: that all stakeholders work together to obtain information, review research and focus on strategies that public safety advocates can use while engaging the whole community and sharing limited resources.

Speaker and psychotherapist expert, Jill Levenson, provided recent studies from several states which showed little significance that registration and notification lowered sex crimes. Failure to register doesn't significantly increase the risk of sexual recidivism. That recidivists did not seem to live closer than non-recidivists to schools or child care centers. And with 700,000 offenders registered in the US, enforcement by law is diluted, it's impossible to track all.

Another trend voiced by presenters was "one size doesn't fit all." Different sex crimes call for varied treatment. One presenter, Katherine Gotch, differentiated the "run of the mill" sex offender to those with "specialty" crimes.

Colorado's own SOMB member, Defense Attorney Rick Levinson, and Colorado Springs treatment provider Lee Oesterlee, jointly presented a seminar on how offenders and their attorneys work collaboratively to reach agreements, particularly in plea bargains. There are no guidelines in the Standards addressing such situations.

DIANE TRAMATOLA-LAWSON  
COMMUNITY CORRECTIONS

Ms. Tramatola-Lawson, serving on the Board of Denver Community Corrections, was the guest speaker at the July 20<sup>th</sup> AFC General Meeting.

She said that what the case managers and the person's boss puts on paper weighs heavily on the decision from the board. In Denver family and friends are not allowed to testify on behalf of the inmate whereas in other counties they are. She is working on getting that changed. She said that the inmates can write a letter to community corrections within 9 months of the time they are up for community corrections/parole and tell them what they have done to advance and why they deserve a chance in community corrections and the board will review it when their case comes up. She said to keep it one page or less though. When they talk about "diversion" they are referring to probation and when they talk about "transition" they are talking about parole.

**Maureen Cain addresses Advocates For Change**

**At the June 22<sup>nd</sup> AFC General Meeting, Maureen Cain, formerly a private and public defender and currently the lobbyist for the Colorado Criminal Defense Bar, addressed attendees.**

**Regarding upcoming legislation, Ms. Cain reported that the Governor's Commission on Criminal and Juvenile Justice (CCJJ) will likely be considering forwarding bills registration and sentencing for those with a sex offense. The CCJJ is the vehicle for getting support for bills dealing with the sex offense issues from law enforcement, prosecutors and defense attorneys.**

**Other issues that might be looked at are the Lifetime Supervision Act, use of polygraphs and the "no known cure" belief.**

**Ms. Cain suggested that AFC work with Circles of Support, a program that provides support for those offenders who are being released but have no support on the outside. She suggested that AFC form relationships with other organizations such as churches and service groups in order to provide the numbers necessary for the support of those with a sex offense.**

**She encouraged AFC members to formulate the message - the message should be about building something that works better than the current system; that we should decide what we want to happen and then find the middle ground. Investing in legislative efforts is important.**

**Labeling v. People - First Language  
by SS**

AFC believes that each person is multi-faceted and cannot be defined solely by just one aspect or experience in life. Similarly, a person cannot be defined solely by any labeling that may be applied, regardless of any official or professional origin.

Thus, AFC discourages the use of labels and encapsulating professional and official terminology when referring to a person and his or her issue(s).

Instead, AFC promotes and encourages the use of what has been referred to as "people-first" language in which a person being referred to is acknowledged by their personhood first, and any issue or other aspect of that person second. For example, instead of referring to someone as a "sex offender," AFC encourages the use of "person with a sex offense." Similarly, AFC encourages the use of "sex offense laws" instead of "sex offender" laws.

**INSIDERS AND OUTSIDERS OPINIONS**

*Opinions from those who have been convicted of an offense and their families*

I would like to share my experience and the difficulty I had locating an apartment willing to accept a sex offender. My search began long before my husband was to be released from CDOC, knowing that it would not be an easy task. It took at least six months of relentless phone calls and determination before I stumbled upon an ad on Craig's List. When I told the property manager about our circumstances and her response was "I don't have a problem with that." I broke down and sobbed. My prayer had been answered. After all the calls and humiliation, I had finally found a place to call home. This meant, though, that compromises were going to have to be made. It wasn't an upscale apartment complex with all the amenities that my previous apartment had, but I found no corporate owned properties that would accept a felon, let alone a sex offender. That being said, I have a place that is home for us. My husband feels that I have "set him up for success" knowing he has a home to parole to and all of his possessions waiting for him. But this experience has left me wondering what happens to all of the sex offenders who are released who have no support. There are places willing to lease to a sex offender but they are few and far between. - a loving wife.

**This special note** is to our loved ones in Department of Corrections or elsewhere in the system, such as on parole, probation, in community corrections, etc. Our group, Advocates for Change, would like to invite **your** family to join our membership. Only through a bigger effort, with more members, can we accomplish our goals. Membership requirement for a family is filling out and returning an application with a \$20.00 fee.
